3 – Year Renewal of Class III Gaming License

Notice: 60 days before the expiration of your gaming license you are required to submit a renewal application to the Mescalero Apache Tribal Gaming Commission.

- ◆ **The attached six - page application must be filled out completely and returned to the MATGC office. If a question does not apply to you, please state so with the acronym “N/A”, or insert the words “not applicable” (Attach additional sheets if necessary).**
- ◆ **The Authorization for Release of Information must NOT be signed until applicant is in the presence of a Notary Public.**
- ◆ **Applicant must bring two valid forms of identification with application. Any two of the following will be accepted (A birth certificate is not a acceptable form of identification):**

Failure to consent to the disclosures indicated in this notice will result in a tribe’s being unable to license you for a primary management official or key employee position. The disclosure of your Social Security Number (SSN) is voluntary. However, failure to supply a SSN may result in errors in processing your application.

FALSE STATEMENT NOTICE

A false statement on any part of your application may be grounds for denying a license or the suspension or revocation of a license. Also, you may be punished by fine or imprisonment (US Code, title 18, section 1001).

I further agree to indemnify and hold harmless any person to whom this request is lawfully presented. Such indemnification and hold harmless includes all claims, damages, losses and expenses, including reasonable attorneys' fees.
